# FINANCIAL RESPONSIBILITY:

Event minimum is \$1,500. A \$500 non-refundable deposit is required to hold your date. Deposit will go towards the final balance. Rental is \$175 per hour for events with 50 or less guests. Rental is \$200 per hour for events with 51 or more guests. 18% gratuity will be added to the full balance including rental and food/beverage total. Payments can be made via cash or credit card. There is a 2.99% discount for payments made via cash. Doors will open for the event 15 minutes prior to the contracted start time. Party renting the facility will have a 15 minute grace period after contracted end time, after which a per-hour fee will be assessed based on the currently contracted rental rate. Event shall not extend beyond 1:00am. Payment is due in full the day of the event.

## CATERING:

No outside food is allowed on the premises at any time unless expressly granted by Clancy's Irish Pub in writing prior to the event. Final headcount is due the Wednesday prior to the event.

## ALCOHOL:

No outside alcohol is allowed on the premises at any time unless expressly granted by Clancy's Irish Pub in writing prior to the event. Off-menu items can be requested. "Last call" will be 15 minutes prior to contracted end time. It is up to the discretion of Clancy's Irish Pub staff to refuse service to anyone appearing underage, overly intoxicated, under the influence of drugs or behaving inappropriately.

## MUSIC ON THE PREMISES:

Live music and similar is allowed, but must be contained inside the premises. Music in any other form is not allowed outdoors at any time- with the exception of Touch Tunes.

## DECORATING:

Party renting the facility will be allowed one, 2-hour decorating period on the day of the event that will be mutually agreed upon at least 48 hours in advance. <u>Decorating must be completed 3 hours</u> <u>prior to start time.</u> Clean up and throw away of décor is included in the rental price. If there are items Customer wishes to keep, they will be allowed a 2 hour window on a mutually agreed upon later date to pick items up. Any décor not removed will be deemed forfeited by customer and will be removed by staff and thrown away prior to Clancy's Irish Pub opening for next business day.
